PRELIMINARY MARKET CONSULTATION PURSUANT TO ART. 66 OF D.LGS. 50/2016

Public Procurement of Innovative Solutions (PPI) FOR THE "RESTORATION OF THE MARINE SEDIMENTS inside the Site of National Interest (hereinafter, "SIN") of BAGNOLI-COROGLIO" - Unique Project Code (CUP): C65E19000390001

To date, the characterization activity has been completed as part of the research project "Pilot Trials Aimed at the Environmental Restoration and Bathing waters quality at the Bagnoli-Coroglio SIN" ("ABBaCO") which integrated the previous campaign carried out by ISPRA (formerly "ICRAM") in 2005 and the Technical Economic Feasibility Plan for the environmental remediation and remediation of the entire Bagnoli-Coroglio SIN has been drawn up.

The complexity of the aforementioned interventions requires the identification an operator with a high technical profile, with high and consolidated experience, including international, as well as undoubted economic solidity who is able to implement as a whole the multiple environmental remediation interventions of contaminated sediments, carrying out both the project development and the implementation phase.

INVITALIA will maintain a punctual and continuous High Surveillance activity on such activities, also through dedicated internal resources and functions.

INVITALIA therefore intends to proceed with the issuing of a public tender, to be carried out in the manner provided for by art. 65 of the Legislative Decree 18 April 2016, n. 50 (hereinafter the "Public Contracts Code"), having as its object the following activities:

- design and execution of a technological demonstration of the innovative remediation techniques envisaged for the remediation of marine sediments;
- final and executive design of the overall intervention for the remediation of marine sediments and subsequent realization of the same.

For this purposes INVITALIA intends to initiate a preliminary market consultation with the publication of the present "Notice", pursuant to and for the purposes of Article 66 of the Public Contracts Code, through which acquire adequate knowledge of the reference market for what concerns the professional profile of economic operators and the experiences they have gained in the specific sector of environmental restoration, with a particular focus on water and marine sediment remediation.

In light of the above, operators who wish to take part in the consultation may submit an expression of interest for this purpose, drawn up with the contents of the form attached to this Notice (Annex 1 - Expression of interest) and may attach to the form any documentation in the format considered as more useful for the purpose as long as it contains the following information:

- total amount of engineering and architecture technical services carried out in the last 10 years, with specific reference to the definitive and executive design phases, in the following categories as referred to in TABLE Z-1 "CATEGORIES OF WORKS - PARAMETER OF THE DEGREE OF COMPLEXITY - CLASSIFICATION OF SERVICES AND CORRESPONDENCES "of the Ministerial Decree of 17 June 2016):
 - **"P.01" - Naturalistic or landscape interventions;**
 - **"P.03" - Environmental recovery and requalification interventions;**
 - **"D.02" - Reclamation works and derivations.**
- possession of SOA certification (Certification Body Certificate) relating to the following categories, indicating the relative classification:
 - **"OG.7" - Marine works and dredging works;**
 - **"OG.12" - Works and plants for reclamation and environmental protection;**
- the carrying out of research and development contracts relating to environmental remediation and / or remediation;
- report (max 10 A4 format illustrative sheets) containing an indication of the services, design and research services and / or works concerning interventions deemed significant by the Operator and similar to those covered by the present procedure. The report must also contain an indication of the equipment of the available machines and systems (ownership, leasing, etc.), of the available computer equipment and of the modeling software used.

Operators based in non-EU member states will be able to provide equivalent documentation in accordance with the regulations in use in their respective countries.

INVITALIA reserves the right to initiate a consultation phase through one or more meetings to discuss with the operators who have regularly presented the expression of interest.

The legal representatives of the operators who have expressed an interest or other persons specifically delegated by the latter will be invited to participate in the meetings which, according to the methods that will be indicated from time to time, may also take place electronically.

- finally, pursuant to art. 67 of the Public Contracts Code, in order to adopt adequate measures to ensure that competition is not distorted by the participation of the candidate or the bidder in the procedure that may be launched by INVITALIA, the information exchanged directly with INVITALIA will be made public and reported in the tender procedure documents that may be launched;
- INVITALIA may interrupt, suspend or revoke the preliminary market consultation, as well as interrupt the consultation of one or more economic operators, at any time, without incurring any type of liability;
- the discussions with INVITALIA during the preliminary market consultation are not aimed at the award of any contract, nor do they attribute to those who intend to participate in it any rights of any kind towards INVITALIA;
- participation in the preliminary market consultation will therefore not ensure and will not preclude participation in the tender procedure that may be launched by INVITALIA, as such participation does not constitute a condition of access, nor any commitment regarding the continuation of the procedure itself. In particular, participation in the preliminary market consultation does not determine, for the individual economic operator, any expectation from INVITALIA;
